# 147. WARD MEMBERS' REPORTS

RESOLVED that Ward Councillors C.J. McGuinness, S.L. McGuinness and F.J. Tyas be thanked for reporting and supplying information regarding:-

- (1) an email sent to Planning on 25<sup>th</sup> March 2019 stressing the need for Gazeley UK Limited, to look at how the bunds on its development site at the West Moor Business Park, relate to the residential properties in close proximity to the same and to engage with local residents about the problems being experienced;
- (2) Borough Council officers had been requested to investigate the entrance to the new Aldi supermarket site, which is considered to be too steep and would cause problems to customers accessing the site;
- (3) the Doncaster Sheffield Airport Masterplan to 2030 included provision for a mainline train station, for which the company had received support; the Airport's Noise Committee had arranged for action to be taken to try and alleviate complaints about noise from training flights, 76% of such complaints being from one person in Thorne;
- (4) at a recent PACT meeting, complaints were raised about anti-social behaviour, parking in Tranmoor Lane and heavy goods vehicles using Nutwell Lane and Wickett Hern Road in contravention of the weight limit for those roads;
- (5) Borough Council officers were investigating the unlawful dumping of asbestos after a number of loads were dumped in the village within a period of 3 weeks.

# 148. LITTER COLLECTION

RESOLVED it be noted that a litter collection had been arranged to take place on 17<sup>th</sup> April 2019 around the Wickett Hern Road area.

# 149. <u>DONCASTER BOROUGH COUNCIL</u>

### RESOLVED

(1) that the contents of an email from Doncaster Borough Council be noted, confirming:-

- (a) there are two more phases for road works in Nutwell Lane, one in 2019/20 (yet to be designed or programmed in) and the last one, including the junction of Tranmoor Lane, in 2020/21;
- (b) the left turn from Nutwell Lane to Tranmoor Lane whilst difficult it is happening occasionally, so this will be investigated when the maintenance works are designed;
- (c) arrangements will be made for the box marking junction lining to be inspected to see if it requires relining before any re-surfacing works;
- (2) that Doncaster Borough Council be requested to:-
  - (a) repair a defective street light situate outside 33 Nutwell Lane;
  - (b) publicise the problems associated with leaving scrap household appliances on the footways outside household dwellings.
