89. WARD MEMBERS' REPORTS

RESOLVED that Ward Councillors S.L. McGuinness and F.J. Tyas be thanked for reporting and supplying information regarding:-

- (1) Doncaster Borough Council officers, in response to complaints from local residents and Ward Councillors, had

investigated the height and position of the bund erected on the Gazeley UK Limited development site, situate off Whiphill Lane and determined it did not comply with the terms of the planning condition relating to the same. Consequently, the developer would be required to rectify the matter to accord with the planning condition;

- (2) Borough Council officers had also been requested to investigate a complaint regarding obstruction of that part of Whiphill Lane situate within the Gazeley UK Limited development site;
- (3) Ward Members would take up the complaints of residents regarding the prevalence of rats from the Gazeley development causing nuisance to local residents living in the vicinity of the site;
- (4) during a recent operation by South Yorkshire Police, 3 quad bikes and one motor cycle had been seized by police for various offences committed by the riders of the same;
- (5) the Borough Council had confirmed that the penalty for the offence of depositing litter in the open air, which had been queried at the last meeting of the Parish Council, was £150.

90. BARTON LANE

RESOLVED that the contents of an email with attached documents from Doncaster Borough Council be noted, which confirmed that objections had been upheld to the proposed Traffic Regulation Order for the introduction of waiting restrictions on Barton Lane, that had been requested by the landowner, Barton Lane Management Company.

91. SOUTH YORKSHIRE PASSENGER TRANSPORT EXECUTIVE

RESOLVED that the contents of an email be noted from South Yorkshire Passenger Transport Executive (SYPTTE), regarding a public consultation on behalf of the South Yorkshire Bus Partnerships, which was being held from 29th October until 9th December 2018, to seek views and feedback on proposed changes to the local bus network.
