74. DRAFT ARMTHORPE NEIGHBOURHOOD DEVELOPMENT PLAN

RESOLVED

- (1) that the natural green wedge to the south of Armthorpe be included within the Draft Armthorpe Neighbourhood Development Plan (the Draft Plan);
- (2) that on the basis of the latest advice received, a Strategic Environmental Assessment be obtained as soon as possible;
- (3) that the responses drafted by Mr. K. Burley to the representations received from 69 residents of Armthorpe, together with 12 from developers and/or their agents and statutory consultees to the consultation on the Draft Plan published on 3rd February 2014, be noted and approved;
- (4) that the responses be published on the Parish Council's website and forwarded to those who had made representations on the consultation Draft Plan;
- (5) it be noted that Members discussed at great length the need for additional primary school places in the parish;
