2. The Plan does not propose a higher level of development than is identified in the DMBC Core Strategy and other statutory Planning policy documents.

3. The land allocations for development within the Plan are fully consistent with the DMBC Core Strategy and other statutory Planning policy documents.

4. None of the proposals is likely to affect a "sensitive area" eg a Site of Scientific Interest.

5. The implementation of policies in the Plan will produce 700- 800 new dwellings and major employment uses fully in accordance with the DMBC Core Strategy and other statutory Planning policy documents.

6. The cumulative impact of the policies and proposals will give rise to significant environmental effects entirely in accordance with the DMBC Core Strategy and other statutory Planning policy documents.
