### 98. CHRISTMAS FESTIVE DISPLAY

#### RESOLVED

- (1) that the 5 quotations received for the hire, installation and dismantling, etc. of a Christmas motif display in Armthorpe, for the 3 year hire period 2021-2023, be noted;
- (2) that the quotation received from Christmas Plus Limited (the company) totalling £32,550 plus VAT for the 3 year hire period, for the motifs in the high budget range, be accepted subject to the company confirming it will:-
  - (a) adhere strictly to the contract terms;
  - (b) liaise with DBC on all matters relating to Christmas Lighting in Armthorpe;
  - (c) comply with DBC's Christmas Lighting Operational Policy (the Policy);
  - (d) assist the Parish Council in complying with its obligations under the Policy;
- (3) that the Clerk to the Council (together with Councillors. C. Brodhurst-Brown, L. Donald and F.J. Tyas) meet with a representative of the Company to undertake a joint site survey to identify (i) the various street lighting columns that are available for the motifs and (ii) any trees that are suitable to be provided with appropriate lighting;

  - (a) the motifs with the Company, if necessary from a combination of its three budget ranges;
  - (b) any additional motifs that may have become available since the quotation was submitted;
  - (c) the costs of any tree lighting to be supplied, installed and dismantled by the Company, together with all associated electrical infrastructure costs to be provided by DBC or a third party contractor;
- (5) that the quotation received from The Christmas Decorators in the sum of £1,158 plus VAT per annum, for LED icicle lights along the roof line of the Community Centre and a festive wreath around the top window on the front of the building, be accepted.
