- (3) that the Sports and Recreation Officer arrange a meeting with Councillors A. Barrington and C.A. Head to discuss a proposal for consideration by the Council, to establish a support group for families and carers of people with mental health issues.

- the opening of Doncaster Gallery, Library and Museum on 29th May 2021, for which admission is free but tickets must be pre-booked;
- (5) a pop up vaccination centre at the Jamia Mosque, Hyde Park, where anyone eligible can just turn up;
- a consultation on the Doncaster Community Safety
 Strategy surveys to be completed by 30th June 2021;
- (7) the South Yorkshire Passenger Transport Executive Travel Pass for 16-18 year olds and the concession being extended to 18-21 year olds from 7th June 2021 for a year, so anyone aged 21 and under can travel on buses or trams in South Yorkshire for 80p a journey.

39. YORKSHIRE LOCAL COUNCILS ASSOCIATIONS

RESOLVED that the extract from the Yorkshire Local Councils Associations Law and Governance Bulletin, dated 24th May 2021, about the powers of a local council, what they are and how they work, be noted.

40. LITTER COLLECTION

RESOLVED

 that a Superbin in the sum of £823.00 plus VAT be purchased for a pilot project which Southfield Primary School will be asked to trial its use;

- that the Council purchase litter picking equipment, i.e. litter pickers, hi-vis vests, etc, up to a maximum of £500, for community use;
- (3) that a proposal to employ a litter picker for Armthorpe for up to 15 hours per week to be paid in accordance with the National Living Wage (current hourly rate of £8.91), be submitted to the next meeting of the Council for approval.

41. PROHIBITION OF THROUGH TRAFFIC ORDERS - VARIOUS ROADS

RESOLVED that the following orders proposed to be made by Doncaster Metropolitan Borough Council be noted:-

- (1) Prohibition of Through Traffic Order to prohibit vehicles from proceeding on various roads in Armthorpe from 1st June 2021 for a period of up to 10 weeks, to ensure the safety of the public and workforce whilst works for gas mains reinforcement are undertaken;
- (2) extension of the Prohibition of Through Traffic Order on Hatfield Lane, Armthorpe from its junction with A630 West Moor Link to its junction with Mercel Avenue whilst works for the construction of a new roundabout are undertaken up to and including 31st August 2021 for:-
 - (i) a series of weekday night time closures between 7pm and 6am;
 - (ii) a series of Sunday closures between 7am and 6pm.

42. DMBC - VARIOUS MATTERS

RESOLVED that the Borough Council be requested to:-

- investigate the closure of the temporary footpath on Hatfield Lane, which was impassable due to construction work;
- (2) consider the provision of seating benches on Markham Main Heath;
- (3) repair uneven paving slabs outside 3 Green Common, which have previously been reported on two occasions;
- (4) investigate and carry out remedial works to prevent the regular flooding of the road surface on Doncaster Road outside the premises of Carpenters Funeral Services and the entrance to Barton Lane;

- investigate the shed which appears to be being used to operate a business within the front curtilage of the residential property 'Brookland', Church Street (opposite St. Leonard and St. Mary Church);
- (6) arrange for the grass to be cut on Wickett Hern Road and Walbank Road, which has not been cut since April;
- (7) arrange for the removal of worktops from the lay-by on the West Moor Link road near to Ikea.

43. SOUTH YORKSHIRE POLICE

RESOLVED it be noted that a response was awaited from South Yorkshire Police regarding the Council's request to re-introduce PACT meetings.

44. <u>COMMUNITY CENTRE</u>

RESOLVED that the banner covering part of the Council's noticeboard at the entrance to the Community Centre, be removed forthwith.
