 - (d) a summary of consultation replies received by the Parish Council;
 - the Strategic Planning Principles and other relevant issues for each proposed housing site determined at the previous meeting of the Group;
- (3) that Mr. S. Smales be thanked for his undertaking to obtain an estimate of the cost of producing a landscape assessment to delineate a Green Wedge along the northern boundary of the Parish;
