21. MINUTES

22. <u>ISSUES REPORT</u>

RESOLVED

- (1) that Smales Planning & Regeneration Services Limited draft an introductory letter for inclusion in the Issues Report;
- (2) that the final draft of the Issues Report (subject to inclusion of appropriate photographs of the village) and a three week consultation period commence during the first week in January 2013 with statutory planning consultees, all developers/landowners and other neighbouring parish councils, with a copy being available for viewing on the Parish Council's website;
- (3) that Councillor S. A. Pickles be thanked for his undertaking to take further photographs of the properties/locations identified for inclusion in the Issues Report;

- (4) that the consultation with consultees be undertaken mainly in electronic form and the Report be made available for viewing on the Parish Council's website, with a few paper copies being made available for inspection at the local public library and Armthorpe Community Centre;
- (5) that notices regarding consultation on the Issues Report be displayed in the local public library, public houses, clubs, local shops and on the Parish Council's website;
- (6) that the local press be contacted with a view to publicizing the Issues Report consultation.

23. PLANNING APPEAL – LAND OFF HATFIELD LANE

RESOLVED that the Secretary of State's decision regarding the appeal made by MPSL Planning and Design for housing and employment development on land off Hatfield Lane, which was refused mainly on grounds of prematurity, be noted.

24. MEETINGS WITH DEVELOPERS/LANDOWNERS

RESOLVED that in respect of the meetings to be held over two evenings at Armthorpe Community Centre on 15th and 16th January 2013, each developer/landowner (who has an interest in or owns any of the land to be allocated for housing and/or employment sites) be requested to provide a 30 minute presentation and supply a 2 page bullet point summary and plan.

25. EXCLUSION OF PRESS AND PUBLIC

RESOLVED that the press and public be excluded from the following item of business on the grounds that the information has been supplied by Doncaster Borough Council on a confidential basis.

26. PUBLIC CONSULTATION

RESOLVED it be noted:-

- (1) that in addition to giving notice on the Parish Council's website, posters were also displayed in the local public library and certain business premises in the village, 6,000 leaflets were delivered to every household and business premises in Armthorpe, advertising the Public Information Meeting held on 28th November 2012 and the Planning Engagement Day held on 1st December 2012;
- (2) that only 86 residents signed the attendance sheet for the Public Information Meeting and approximately 10 others attended but refused to sign the sheet;

- (3) that only 47 residents attended the Planning Engagement Day, the majority of which indicated their preferences for and submitted comments on the housing sites that were subject to the public consultation;
- (4) that the summary of the consultations circulated at the meeting be noted.
